2. Visitor Policy – The school Board reaffirmed the electronic vote of the Wentworth School District Visitor Policy. - Discussion ensued at great length with many opinions on various aspects of the policy.

Privilege of the Floor – Carla Chierichetti asked if the school would be doing a school play this year. Mr. Charpentier stated probably not because there is not anyone available with the time. Parents could put on a play if there was desire. It was requested to put the information in the newsletter to spread the word to parents who might wish to volunteer.

Francis Muzzey- States that after nonpublic meeting last month he asked to see the checks. While inspecting the checks he noticed one written in excess of \$2,000.00 to the NH School Board Assn. Mrs. Mack pointed out that when it was brought to the School Boards' attention they did thank him for noticing.

Deb Gelsi questioned the increase in school lunch combined with smaller portions. It was explained to her that the State sets the prices for school lunch as well as portion size. It was also noted that WES lunch is made based on children's requests for that day and told that if available children may get seconds. Mrs. Sanborn did also note that children may not always choose all of the food selections available to them on that day and Mr. Charpentier shared that children also get the fresh fruits and vegetable at snack time every day. Ms. Gelsi also asked what the stipend for Mr. Charpentier was for. The board noted that it was in lieu of a raise.

Edward Crane asked if the school can anticipated budget changes based on children that are coded. Mr. Charpentier explained that this is what happens once a child is enrolled and coded for future attendance. Mr. Crane also inquired about PTO and his interest in playing a roll if it could be recreated. After open discussion and other parents will to see it come back, it was decided to put information into the newsletter in order to reach out to other parents.

Mr. Muzzey noted that anticipated deficit is unable to diagnose in advance and the borrowing money cannot be done. Instead the deficits get documented and ask for a deficit appropriation.

The purpose of the meeting was to inform and discuss with parents teacher re-assignments for grades 5-8. A discussion ensued regarding the use of Title I money to create classroom teacher support for grade 5 students in the areas of English Language Arts and Mathematics. Sara Byers would provide Title I Mathematics support with grade 5 students. Erika Clark would provide Title I English Language Arts support with grade 5 students.

Parents asked about certification requirements for teachers in grades 5-8. Ethel Gaides explained that the teachers being hired with Title I funds in grade 5 are certified as K-6 teachers. Teacher requirements for grades 7 and 8 are subject specific with Middle School or grades 7-12 certification required in the subject area.

Parents expressed their concern that a divider was needed to separate the grades 5/6 classroom. They asked the school board to check to see if a divider (not being utilized) in any of SAU #48 schools may be available that Wentworth could have for the grades 5/6 classroom. It was suggested that a warrant article be included in the 2013-2014 school district budget for a divider if no divider can be located for Wentworth.

Parents expressed their concern that there is no formal spelling program in grade 6. Parents wanted the school board to consider an after school homework program. They mentioned the grant that Warren Elementary School received for an after school program. It was suggested that a warrant article be included in the 2013-2014 school district budget for an after school homework program.

Principal's Report-

The National Center on School-wide Inclusive School Reform called the SWIFT Center (School Wide Integrated Framework for Transformation) has nominated Wentworth Elementary School as one of a select group of schools nationwide to become a "Knowledge Development Site (KDS)" on the basis of our success in implementing exemplary inclusive educational practices. A phone interview was

conducted on Jan 2nd. The school will know within the next few weeks if we will move forward on the selection. 64 schools across 18 districts within 4 states will be chosen. I think it is a great honor for our school to be nominated and recognized for all the great teaching and learning we provide our students.
