**June 4, 2019**

Called to Order: 6:00 p.m.

1. Pledge of Allegiance
2. Put off until next week approval of minutes of previous week

Morgan – Explained that the order of the Agenda had been changed.

Mack – Septic system design was submitted to the Board for approval.

Muzzey made the **motion** for the Town to accept the septic system design and Omer 2<sup>nd</sup> it. **Motion carried.**

Currier stamped the plans, signed her name and dated it.  
Omer signed and dated the plans as well.

Mack thanked the Board for their approval and for being early on the Agenda.

Muzzey – We need a copy of the design.  
Mack – I will get a color copy to you.

Mr. Pierhall – I have an issue/concern. Did the Town approve the letter sent out by Avitar?

Omer – We received and reviewed the letter.

Mr. P – Who selects the homes to be assessed?

MC – Avitar does.

Mr. P – Does the Town review the assessment and make sure that it is correct?

Mr. P - How can the Town be sure that the assessment is done correctly? Is Avitar compensated by a percentage of the amount assessed?

MC – Read from the contract between the Town and Avitar.

Mr. P - I looked online for the document that Morgan read from and could not find it. I would like a copy of the contract that Morgan read from.

Morgan read that there is no percentage given as a stipend.

Omer, Muzzey and Mr. P want copies of the document.

Muzzey – We got a list of people not pleased with the assessment and we sent it to Avitar.

Mr. P – That is a different matter. When I first moved here and was assessed, I met with an Avitar agent and a Town Selectmen. They had a “view tax” and it is subjective.

There was short discussion regarding the view tax.

MC – Tanya sent out a letter stating informing residents about the tax assessment that was going to happen. In January, the Town received the first email about it from Avitar. Avitar sent out a letter saying that they would not assess a property unless they had sent out a letter in advance. She read from the letter.

Mr. P – The letter does not give enough time/warning (15 days) for the owner to respond regarding the reassessment. What if it is not at a convenient time for the home owner?

Morgan – Unfortunately, it gets costly to the Town because we would have to send out registered letters and to be frank, we have gotten a lot of complaints from the Town. Maybe we need to reevaluate who or what company does the assessments.

Kay - Was there a letter sent out to all the residents of Wentworth?

MC – No, only to the ones being assessed.

Muzzey – In my opinion, a person should not be reassessed more than once in a 4-year period.

Omer – I appreciate you coming in. Could we have a copy of your questions you have? Maybe we could get a better response about your concerns. We could use them and talk with Avitar.

MC – Is there any new business from the public that we need to address?

None.

Randy Ruger – I need an electronics pickup.

MC – We need this in writing so we can see about arranging it.

Randy- We had a busy weekend. Could I call someone in for a couple of hours to help?

Muzzey – Do you have any applicants?

R – I have an idea.

Omer – Is it in your budget?

Morgan – I do not have a problem with this.

Omer – Do they need a certification?

MC- How old do they need to be?

Randy -18 Yrs.

Muzzey – If you get too busy, just give me a call and I will come down and help.

Randy – I will post what people can bring in. I have concerns about people picking up things and selling them.

Morgan – Do you have proof that people are selling the items?

Randy – Yes. I will not give names, but it needs to be stopped. I will put a notice up that people can take what they need only for themselves.

Randy (referring to Muzzey) – I will talk with you later.

Chief – I would like to give a report only every other week if that is acceptable. If I need to report on something in between the two weeks I will do so.

Muzzey - Made a **motion** that someone sign the federal excise tax stating that all the Town is only using the diesel for Town purposes.

Omer – I second the motion. **Motion carried.**

Chief – Are we moving along with the Agenda?

Morgan – Because the meetings are going so long, we are trying to get all the public things first, out of respect to those who come, so they can hear and get everything done that is possible in their presence.

Road Agent (R/A) – I was not here last week. I will not be here next week as my daughter has an academic thing. In Town, we had some issues last week. Two culverts need/have to be replaced. I got a new estimate that is less.

MC – There is a mention for emergency.

R/A – If I do not order all the culverts at once we do not get a deal on the delivery.

MC – I understand that, but there is a difference between a necessity and the almost 3000 dollar amount that you ordered.

MC - You gave us a list of 6 projects.

R/A – I'm really only getting 20-footers.

Muzzey – I have two issues with this. There is the handbook and getting Board approval is a must.

R/A – I was hoping to get your approval last week and I still do not have it.

Muzzey – It takes time.

R/A- I will say this so that you understand. I have used \$100 worth of stone and will have to get more until we have the culvert. I know that I should have asked but I have already saved the Town money.

Muzzey – I still do not know why you did not get Board approval.

MC – It is just that I am worried about next time. If you think we have taken too much time, then you will just go ahead and order without Board approval.

RA – Most of the Town culverts need to be replaced. In the construction world we needed this, so I took care of it.

MC – But this is not the construction world. This is a small town where money has already been spent on a truck and the money is so tight that anything over \$1000 needs to be Board approved. I do understand that saving \$150.00 would have covered some expense but you ordered this yesterday. Couldn't it have waited 24 hours until today?

RA – Waiting for this will cost more on drains. What if there was a rainstorm? It would all wash out and we could save money if we order this way.

MC – Even so, we are a small town.

RA – I didn't think that \$3000 was a bad deal.

Muzzey - How many feet of culvert would you have to buy to get free delivery?

R/A – It is not just that. It is that we need this, and many are rusted. I apologize for ordering them, but I can say that they are not going to be sitting in the work shed. I will gladly pay the 10 dollars to make up the difference if that is what you want.

R/A – Regarding my license, I didn't pass the pre-trip. The seat belt was not tight so I will have to go back. It was almost two hours for the pre-trip. I am scheduled for the drive part in two weeks.

R/A – I have had several complaints from Town people. The complaint is why haven't we been digging deeper when grading?

R/A – Donna King and her husband are upset about East Side Rd by King Lumber. We already filled in potholes three times with cold patch and it is not working. Donna King is willing to come in and talk with you.

R/A- Am I understanding that the state used to plow to the bottom of the hill? Does the town not own the road by King lumber? There is a section that has not been paved.

Muzzey – I do not know for sure, but it is my understanding that we are responsible for all of that. Can someone correct me?

Chief – The Town took that over. It is the towns responsibility.

R/A – There is a 397-foot section that is not paved, and no one knows why the State and Town stopped at either end.

Donna King has been very nice on the phone and I have met with her. It should be dug up instead of putting hot patch on.

MC – Do we want to invite Donna King to a meeting and talk?

Muzzey – What is your recommendation?

R/A – We need to cut out sections of the road. The real solution would be to pave it, but I do not have money in my budget. It would take a lot of money to cut out sections and fix it correctly.

Muzzey – I do not understand why the State is not doing this.

RA – It has not been paved or taken care of for many years.

Muzzey – How much impact from the King Industry trucks has caused this damage?

Janice Thompson – What he means is that the trucks going back and forth all day long causes lots of damage.

Muzzey – How much does it cost to patch it?

MC – I recommend inviting Donna and her husband to a meeting.

Omer – We need to have more information about the Memorandum of Agreement.

Muzzey – It has been plowed and maintained for years and years.

MC – We will invite them to a meeting to talk about this.

R/A – I think we still might be able to use some money from the State grant that might be enough to fix it.

MC – That money was used to purchase the truck, so there is none left.

R/A - Could you please look at the proposal for bids?

Omer – He does not have it with him.

Dr. Scheller spoke about a fund raiser on the bridge to assist with the **Veterans Memorial** project. He stated that it would be during Home Day and would like permission to do it.

Muzzey made a **motion** for the Chief to know and be in attendance on 3rd of August dinner on the bridge event.

Omer – 2<sup>nd</sup> motion. **Motion carried.**

MC - Veterans are there for the Memorial Fund Raiser.

Omer – Dr. Scheller said it is a Fund Raiser.

Muzzey – Requested the key box be taken out. **Motion** made to table until next year.

Omer – 2<sup>nd</sup> **motion. Motion carried.**

MC - Key box tabled until next year.

Janice Thompson – Does the Town have money for Frescoln and Cross Rds project?

MC – There is money for Frescoln and Cross Rds.

George – My plan is to look at the wording for expenditures.

Muzzey - I heard your questions, but I do not understand what you are saying.

George – Are you talking about emergency spending for any department?

MC read from the handbook.

R/A – Does this say anything about bulk purchases?

Muzzey – We have a guest and I would like to make a motion that we allow our guest to speak.

MC – I do not think that we need to make a motion to allow our guest to speak.

Senator Bob Guida (State Senator for District 2) gave a briefing on activity in State Government. Topics included: a veto from the Governor, 90 million-dollar difference; Education is going to get help - back to original amounts to fund Towns; Fully-funded kindergarten.

DHHS – Mental Health and opioids will get funding.

Senator Guida – I voted against recreational use of marijuana in NH. What is in Denver, we do not want here!!

There was a brief discussion regarding his briefing.

Palmer – I was at the Planning Board last night and there are three different agencies doing studies on culverts in our Town and we are paying for it.

Morgan – I have the information from the meeting.

Muzzey – I want to do something about Primex.

Morgan – This is an increase that is due by June 14<sup>th</sup>.

Muzzey – This is an increase of 30% in 3 years.

Omer – I know that the County is given breaks.

Chief – I looked into Primex initially to see what they would save the Town and the savings was a significant savings.

MC – I don't know if this increase is more than 10%.

Chief – It would be good to look into the increase since Primex took over.

Muzzey – It would be good to look into how much we have had to get Workman's Comp since we took on Primex.

Chief – Is our contract up for renewal?

Omer – I have read contracts for years and it is amazing how much wiggle room is put in contracts. I would like time to read this.

MC – I do not have issues with that.

Muzzey brought up Transfer Station monitoring.

Muzzey – It has been passing the Good Housekeeping seal of improvement year after year.

There was a short discussion regarding the Transfer Station.

All sign Payroll.

Omer – I make a **motion** that we go into **non-public** per RSA 91-A:3 11 (c) - Matters which, if discussed in public, would likely affect adversely the reputation of any person, other than a member of the public body itself, unless such person requests an open meeting.

8:15 pm

There was a discussion regarding properties in arrears for taxes after 3 years.

There was a discussion with the Property Owner, the Selectmen, and the Town Clerk about payment arrangements.

Omer – Made a **motion** to go out of non-public and moved to seal the minutes from the just completed non-public session because they could affect the reputation of someone other than those of the Board of Selectmen. MC 2<sup>nd</sup> motion. **Motion carried.**

Omer – I make a **motion** to go into a 2<sup>nd</sup> non-public per RSA 91-A:3 11 (a) - The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a meeting and (2) requests that the meeting be open, in which case the request shall be granted.



MC – 2<sup>nd</sup> **Motion carried.**

Chief Trott was asked to stay as an important source of information.

Omer – 2<sup>nd</sup> motion. **Motion carried.**

Public – Discussion regarding a person to take Deb Vlk's place when she is not here.

Deb Ziemba also expressed interest.

Chief Trott suggested speaking with Linda Franz.

Muzzey – Does Tanya have a contract? Why doesn't the Administrative Assistant do the Payroll?

MC – Her hours are only 32 hours. She would have to work another 8 – 10 hours.

Muzzey – When I did Payroll, it only took me two hours. Tell where the money is coming from.

MC – We do not know. But it has to come from somewhere.







Meeting June 18, 2019**

**Board Members Present:** Francis Muzzey, Morgan Currier, Omer Ahern Jr.

**Other Attendees:** Linda Franz, Trustee of Trust Funds; Tanya Vela, Administrative Assistant; Paul Manson, Road Agent; Palmer Koelb; Janice Thompson; Kay Bailey; Donna King; George Morrill, Trustee of Trust Funds Chairman; Chief Trott

**Time: 6:09 PM**

**Chairman Francis Muzzey called the meeting to order at 6:09 PM.**

**Public Comment:** Donna King reported on dog(s) running free on East Side Road. Police Department, by her comments, was verbally notified. There is a leash law in town.

**M. Currier:** Spoke of limitations of Police Department and asked Donna King what her recommendation is.

**D. King:** Said she wants a better leash law and on public roads.

**F. Muzzey:** Is it legal for the Select Board to make a regulation greater than the State regulation.

**Chief:** You can make that restriction under an ordinance as long as it doesn't violate any constitutional law like the alcohol ordinance down on the beach here.

**Chief Trott:** The Animal Control Officer just issued a citation for a 2<sup>nd</sup> offense - \$200 (1<sup>st</sup> is \$150)

**F. Muzzey:** I have 3 dogs on a leash that sometimes get off.

**Chief Trott:** I believe it's about intent.

**Donna King:** Every time I walk my dog I'm kind of in a panic state. This seems recent. I keep my dog on a leash.

**Omer Ahern:** Have a public hearing to change ordinance. Also when they come in to register dogs remind folks of the rules, ie. leash laws and ordinance.

**M. Currier:** The town clerk can have the dog owner sign acknowledgement

**F, Muzzey:** May not be enforceable

Just inconsiderate

**F. Muzzey:** Or let us know if it's working for you

**M. Currier:** Will work with Chief Trott and look at what other towns do. But it looks like it is being enforced.

**Donna King:** Please inform the people - remind about leash law

**Omer Ahern:** If we can at least have a notification that the leash law was given to them.

**M. Currier:** Okay, next issue.

**Donna King:** Asked out of curiosity and wondering if there should be a "stop" sign on East Side Road at the intersection of Buffalo Rd, on south end of East Side Rd. There's a "stop" sign at the end of Buffalo Road. One could easily hit people. Seems like there's a need to be a "stop" sign at this location.

Discussion ensued as to various options to repair the road in question, using signage, filling pot holes, etc.

**F. Muzzey:** Add Long-Term Goals (Agenda) - Consider putting a Warrant Article in to consider paving Red Oak Rd.

**Palmer:** A couple of years ago we had 80,000 to fix Riverside Park and the SB had the money to fix it and didn't.

**M. Currier:** If the Select Board signed off on those projects – if FEMA – from Hurricane Irene, the State or Federal Government is not going to help

**Palmer:** Call State Senator Bob Guida and he will have it fixed in 6 months. He has a backbone.

**M. Currier:** Please call. These are things that the Town can not take on. Please, by all means, we need help with their views on projects.

**M. Currier:** Perfect example is the Transfer Station grant that expired b/c it didn't used.

**Motion of F. Muzzey:** To give Palmer Koelb the authority to make calls on behalf of the Board of Selectmen to the State Senator Bob Guida or to others. **Omer Ahern: seconded. Currier voted yes; Muzzey voted yes; Omer Ahern voted yes. Motion Carried.**

**Select Board:** Thank you very much, Palmer for bringing that up and for taking that on.

**Omer Ahern:** Please keep us posted, Palmer, as you go along

**Omer Ahern:** The Town's going to have to make choices going forward.

**M. Currier:** If people don't come to the budget meetings, the things that are important... only the Board and Dept Heads...

**Currier:** Any other public comments? These are discussions – roads – that we will have many, many, many times. Now, that Glenda Toomy is here – We discussed different programs – for elderly – a reach-out program for those unable to get out of their homes, possibly children's programs or tying the two – I mentioned the Jr Honor Society is looking for projects. Sso if anyone has ideas, it would be nice to come up with a community calendar.

**Donna King:** Have a community club?

**Omer Ahern:** Would you like to start that?

**Donna King:** Yes – I can do that.

**Muzzey to Road Agent:** Does Dorchester have a Road Agent yet? In the interest of continuity...

**ROAD AGENT:** There's a very young kid – R. Morrison's step son, Dylan, is working under Smith.

#### **POLICE DEPT:**

**Chief Trott** reported being done with the OHRV Patrols grant, matching grant that he applied for at no cost to the Town.

#### **Transfer Station**

**M. Currier:** Randy Ruger asks if Admin. Assistant is on email exchange. Sticker Mule won't do one-up mule system. Too complicated. The Town can't use them if the Town wants to have a numbering system.

Discussion ensued as to the various "Transfer Station Sticker" options.

**F. Muzzey:** Made a motion that **M. Currier** be authorized to sign for the two (2) septic designs requests. The motion carried and the designs approved.

**Omer Ahern:** I only have a problem with the fact that I can't look at this while listening to the people.

#### **HWY DEPT REPORT**

**Road Agent:** Last Thursday Donna King called relating to a piece of rebar sticking out of road. In checking Road Agent found it to be a property marker on Glenn Campbell's property where people keep cutting the corner at the end of Red Oak Hill Rd on East Side Road. The Road Agent placed rocks around the property marker.

**F. Muzzey:** Red Oak Rd is the only road that is that width (four rods).

**Road Agent:** A property marker is a property marker. I can't touch it. I'll get thrown in prison. I'm just letting you know why the rocks are there. It's a corner pin, this piece of wrought iron

**Chief Trott:** Suggested there are requirements that say it has to be set back from the travel portion of the road.

**Road Agent:** Suggested pulling the road back to where it's supposed to be (**Currier** agreed to idea).

**Omer Ahern:** A letter needs to go to the landowner. Do we have a copy of his deed to look at it? If the Town is encroaching on his property, we have an obligation to work with him. The Town needs to protect the landowner's rights.

**Road Agent:** Next point – there's a pile of household trash in our pit just before a sign that says Moosilauke Campground on Rte. 25 – at our old pit – there's trash in there – household items – pool table, looks like all the guard rails and wire the Town removed from Buffalo Road dam site– pile of poles and wires and guard rails. Just want to make the BOS is aware of that.

**F. Muzzey:** What's your plan on utilization of that pit? There are piles and piles of beautiful granite there.

**Omer Ahern:** I think the Veterans Memorial is looking for some stone like that.

**Linda Franz:** I will let Mr. Scheller know to contact Road Agent about the stone at the Town's gravel pit. It may be used for the Veteran's Memorial Project.

**M. Currier:** Just want to share that we've gotten very good feedback and good talk at the responder's dinner on the good work you're doing.

**Road Agent:** Culvert on Cheever Rd that's rotted and has disintegrated and needs a culvert replacement.

**Omer Ahern:** Very concerned about the addendum. It's an Adhesion Contract. It's a Bait and Switch. Ref: Amending a contract from May 22<sup>nd</sup>. Concerned about the entire contract.

**M. Currier:** HEB Engineering gave explanation.

**M. Currier:** Asked the Administrative Assistant to respond to C. Fournier and let him know to the best of the Board's knowledge, the brook in question is called Rocky Pond Brook.

**M. Currier:** I will contact C. Fournier and let him know there's a new Select Board and we'd like him to come in and meet with us.

**M. Currier:** Trustees of the Trust Funds. Thank you for waiting patiently.



**F. Muzzey:** Do we have 3 Trustees of the Trust Fund? That was the question I wanted to ask. I haven't researched but I think the law requires we replace someone ASAP.

**M. Currier:** But we have to have someone willing to do it? The Town cannot force people.

#### **7:45 P.M. - DISCUSSION ABOUT PAYROLL/VENDOR PAYMENTS**

**M. Currier:** Issues pile up. I would like the Board to meet every other week.

**Omer Ahern:** One of the issues is that there is way too many new people here. To me, there is just way too much that's coming to the attention of the SB but – I request respectfully to have documents ahead of time before I am asked to sign them at or during a BOS meeting.

**M. Currier:** If you didn't want to meet every week, what would you like to do?

**Chief Trott:** I'm a dept head and I'll weigh in. Meeting every Tuesday is at times counterproductive. I still have an obligation to dept b/c in for 3-4 hours. All these things takes time. My position: I think we could manage every two weeks. Productive proactive and positive. I want to be P Chief. I think that's the direction we all need to move in.

**F. Muzzey:** But we still have to do things as members of the BOS in a timely fashion.

**Omer Ahern:** NH is known for the most volunteers in the state.

**F. Muzzey:** I agree with your use of volunteers.

**Time:** 20:14 / Payroll issue and Meeting every other week / Moving time up on Mtg

**M. Currier:** So, knowing your concerns, Francis, is there any feedback from the residents.

**Linda Franz:** I think the 2-week is a better idea. Like the Administrative Assistant said, getting in touch with someone can take a long time.

**F. Muzzey:** This isn't a task-oriented Board, it's a decision making Board.

**Currier made a motion to at least try to meet every other Tuesday and see how it works. Omer Ahern seconded. Muzzey voted NO; Omer Ahern voted yes, Currier voted yes. Motion carried 2 – 1.**

**M. Currier:** Okay, so next meeting is July 2<sup>nd</sup>.

Any discussion on moving the Board meetings up to 5pm?

**Currier made motion to move meeting to 5 pm, Omer Ahern Jr. seconded. Muzzey abstained; Currier voted yes; Omer Ahern Jr. voted yes. Motion carried.**

**M. Currier:** I have no problem coming in weekly to sign payables weekly

**Omer Ahern:** Willing to do so also.

**F. Muzzey:** No reason not to meet to sign payroll.

**M. Currier:** fine with me

**Omer Ahern** No problem coming in to sign checks.

**M. Currier:** have no problem.

**Omer Ahern** I'm here to be a servant of the people and to be as efficient as we can be.

**M. Currier:** So the question is we work out a way to pay vendors weekly and payroll remains every 2 weeks.

**F. Muzzey:** Where is the money coming from?

**Deb VlK:** Look at the list - \$5,000 / \$4611

**Currier: Motion to accept Linda Franz help with Payroll in a volunteer capacity with understanding at looking at a way to compensate her for her time. Omer Ahern seconded. Muzzey abstained; Currier voted yes; Omer Ahern Jr. voted yes. Motion carried.**

**Tanya:** Ask that Linda Franz provide Administrative Assistant with hours spent

**M. Currier:** Anything else on Trustee's behalf? Linda Franz?

**Linda Franz:** We have a good check going out to the cemeteries – will gather things for Tammy at Crane and Bell for audit.

**F. Muzzey:** wants to discuss in non-public recommended wages for personnel.

**Adm. Asst.:** Duane Brown requests to borrow chairs/tables from Town Hall and from whom he can borrow a key. **FM** yes, but not take any of the antique chairs. **OA/MC** yes. Only folding chairs to be loaned.

**Time: 20:48:** Motion on PO Box

**Omer Ahern:** Is it alright with the Select Board to call Mr. Pierhall (?) back and speak with him. **FM & MC** have no issues.
