6:49 Craig Pasco has opted not to accept a nomination as an alternate member for the 2020-2021 term. We thank Craig for all of his help in the past.

6:50 ICER LLC is before the board for official meeting with Plat Plans and Topography Plans for 219&223 Mount Moosilauke Highway (Old dog kennel property. Scott Sanborn is present to answer any questions. Registered Mail abutter notices have been returned. John Meade has a conflict of interest with the minor subdivision and recuses himself from discussion and voting.

Madame Chair recognizes Scott Sanborn of Cardigan Mountain Surveyors. Plans have been distributed to the full board electronically as well as plans in paper format are distributed to all members present. Scott once again explains the 18.2 acre lot is being subdivided (2) 6+ acre lots and (1) 5,5 acre lot. He makes comment that the plan is the same as the preliminary minor subdivision except the pins are now installed on all three lots as well as a note 5 has been added at the board's request last month signifying the use of the driveway easement to lots 2&3 up the hill.
