Warren Davis updated the board on the recent inspection by the State Health Inspector and will follow up again in 30 days. The State requested the Town review the RSA's related to the Health Officers responsibilities.

Selectmen agreed to request the highway department post Saunders Hill Bridge for "Weight Limit 6 Tons per the recommendation from DOT.

Selectmen agreed to accept the quote of \$1,462.00 from Skowhegan Press for the 2005 Town report.
