Steve moved to open the meeting at 6:00 pm, seconded by Randy and approved.

Randy motioned, seconded by Steve and approved to go into a Non-Public Meeting at 6:08 pm per **RSA 91-A:3, II(b)** – Consideration of the hiring of a public employee. Motion to hire Shiela Quinto-Truskowski, for clerk support, seconded by Randy and approved. Motion by Steve to come out of Non-Public session, seconded by Randy and approved at 6:22 pm.

Chief Kevin Kay stated the department is still very busy processing the burglaries which occurred last Fall. There were no questions from the public at this time.

Linda Brownson addressed the Selectmen. She would like to see North Pass added as “other business” at the end of next week’s Town Meeting. She would like to get feedback from other town residents, and requested to put up a table at the town meeting. Selectmen stated that this would be ok. Steve stated that he’s neutral in his position to North Pass. Discussion followed regarding the land and residents that will be affected by the North Pass alternate route. Craig Pascoe presented a wall diagram illustrating residents and land that will be affected by the proposed alternate route. Craig listed the names of residents that will be affected by this pass. After listening to input from residents and studying the impacted areas, Steve changed his position to against the Northern Pass. Steve motioned that the Wentworth Board of Selectmen officially oppose both the proposed route and the alternate route in regards to the North Pass Project. This motion was seconded by Randy and approved.

Quentin Mack, stated that there will be a discussion of the North Pass on Friday, March 18<sup>th</sup>, at the Hanaway Theater on campus at PSU, from 6:00 pm – 9 pm for those that are interested. Quentin also stated that he is on the agenda for the Town of Orford next Wednesday at 5:30 pm, to discuss the North Pass.

Donna King made available scope statements in opposition of North Pass, which many attendees signed. The forms need to be received no later than March 9<sup>th</sup>, and Donna offered to mail these.

Steve requested that we place on the agenda for March 15<sup>th</sup>, to have a discussion regarding properties in which transmission lines currently run through. Steve would like to discuss whether these property owners currently are given a credit/ depreciated value due to this.

Steve made a motion that the Board of Selectmen communicate to the State’s Offices (Governor John Lynch, Senator Jeanie Forrester, Executive Councilor Raymond Burton, House of Representatives Charles Brosseau and James Aguiar) their unified position of opposition to the North Pass project, this was seconded by Randy and approved.

Steve also discussed with attendees his position that it is the responsibility of all to improve costs and availability of energy by using practical and cost effective generation and distribution solutions. It is Steve's desire to move forward and continue to keep the discussion open regarding energy consumption.

Francis motioned to open the meeting at 6:00 pm, seconded by Randy and approved.

Bernie Sullivan stated she had concerns regarding the recent town election and inconsistencies regarding late registry of candidates as well as write-in candidates, and she wanted these concerns to be on record. Discussion followed regarding both issues. Bernie stated that she had heard that there was possibly someone on the ballot that registered after the cut off time and that there was also an individual wanting to be on the write-in and was not allowed to do so due to the cut off time. Donna King stated that she is in the process of looking into whether or not someone was on the ballot that may have registered after the deadline to do so, which she takes very seriously, and that her desire is to do fairly to all.

Kathleen Springham-Mack also inquired as to the impact that this might have on the recent elections. Donna stated she has spoken with the Attorney General's Office and the Secretary of State's office, and has been informed that this would not create the need to have another Election. Donna stated that she will keep in contact with Bernie and Kathleen, as well as the Board of Selectmen regarding the outcome of her findings.

Chief Kevin Kay gave a Department status update. He stated the Department is dealing with roadside signs have been removed by juveniles. They are also still working and dealing with the past burglaries, and pending indictments. Chief Kay also stated that he is in the process of hiring an animal control officer, possibly from Piermont. Francis motioned, seconded by Randy and approved to give the authority to Chief Kay to carry out the hiring process of an animal control officer. A brief discussion regarding the procedures for collecting stray dogs followed including warnings, discussion of dog regulations, and fines. Chief Kay also stated that the cruiser will be in for inspection this week.

Roy Sabourn presented a FloodPlain Development Application and site plan map on behalf of Linda and Ronald Franz, M/L 05-04-03. Mr. Sabourn and the Selectmen discussed the shoreline indicators, woodland buffers, protected areas etc. Mr. Sabourn stated they have not yet applied to DOT, as they wanted to speak with Board first. Francis discussed the Town's Floodplain Ordinance, and wanted Roy Sabourn to be aware of it. Roy said they are not doing a subdivision. Motion by Francis that the board accepts the proposal with the stipulation that the Franz' follow the Floodplain Ordinances of the Town, seconded by Randy and approved.

Francis motioned to open the meeting at 6:00 pm, seconded by Randy and approved.

Chief Kay stated they are going to hold off on removing the snow tires on the cruiser for the time being. He stated that the department has received an application for an Animal Control officer. The Selectmen's office will coordinate with Chief Kay to schedule drug testing. Chief Kay told the Selectmen that Sargent Pivrotto is assigned specifically on Wednesday/Thursdays to handle the investigation related to the burglaries. He has been trying to deal with the work associated with the burglaries while on regular duty, and is unable to devote the needed time. This will allow him to concentrate on just the burglary investigation. Chief Kay reported that he was out and about Sunday, and noted that there are some road concerns. He stated he believes that it is a bit worse than in recent past years. He stated that the bus made it around on Friday and today, and feels that emergency vehicles should be able to do so as well.

Chief Kay talked with the Selectmen regarding the Dept of Safety annual safety report. Selectmen discussed the possibility of having each Department head perform their own safety inspection. Chief Kay suggested that this be done every 6 months or possibly quarterly.

Chief Kay also discussed the mobile equipment list to be updated for the Local Government Center. Selectmen discussed the insurance deductibles. Chief Kay recommends that we update the list to include such items as the radar units, portable radios, and difibulators. Steve asked that the office speak with the LGC regarding costs related to adding additional property.

Carol Freidrich stated that she is pleased the website which lists forms for the Police Department, and feels they are very helpful.

Gary Lavine, of Zero Sort discussed with the Selectmen Zero sort's process. Gary explained that through education, the town's resident's will learn what types of products are recyclable. He explained that there is no need to separate types of recyclables. Steve asked for a summary of what can be put in the containers. Gary stated that most all recyclables can go in. They accept cardboard, plastic food and beverage containers, empty aerosol cans (no hazardous fluids), Aluminum and metal cans, newspapers, and magazines. The containers will have a roof and 4 doors down each side. The Selectmen discussed what types of items cannot go in. Francis inquired about penalties related to residents throwing in unacceptable items. Gary stated that most of time a warning is given, and if it continues, a fee. The warning will tell you exactly what the rejection is due to. He said they usually find it is the garbage bag that the resident has used to haul the recyclables in.

Randy motioned to hire Zero Sort, seconded by Steve and approved. Gary is hoping to have the containers set up within the next week, and will bring brochures to hand out to residents explaining how Zero Sort works.

Chief Kay mentioned possibly contacting New Hampshire The Beautiful. Steve talked about possibly having an Advisory Board assembled. Palmer suggested talking with Kenyon Carl and possibly getting him involved.

John and Janice Thompson were present, and wanted to discuss the latest information regarding the North Pass. Janice said they attended the recent meeting which was held in Plymouth on Friday, March 18, 2011. She stated that she asked the panel if the proposed and alternate routes are not approved, what will happen - will they use the existing lines? She spoke with someone from Dept of Energy after the meeting. The DOE stated that if North Pass is turned down for both the Proposed and Alternate routes, they will then petition the DOE to use the existing lines, which will have to be widened one side or the other. Janice presented a copy of the map she received at the town meeting from Linda Brownson to the Selectmen, and requested that she be able to leave copies of the map along with a Public Comment Sheet which can be submitted to the DOE no later than April 12, 2011 to be considered in the scoping process. She is planning on contacting residents that will be affected regarding their ability to protest which needs to happen by April 12th. Selectmen agreed to allow Janice to place these items in the lobby.

Francis discussed the Wentworth Landfill Groundwater Sampling & Reporting which is done by Provan & Lorber. Francis motioned that Randy sign the 2011 contract, seconded and approved.

The Selectmen discussed selection of chairman for this year. Francis nominated Randy, seconded and approved. Randy stated that rather than the Chairman receiving \$2,600.00 and each Selectmen receiving \$2,000.00 per year, as in the past, he would like to have all 3 Selectmen receive the same amount of \$2,200.00 per year. Motioned by Randy, seconded by Steve and approved.

John Vlk discussed his abatement application. Cross Country has made a recommendation that this abatement request be granted, as the home was previously listed a residential, but is actually a double wide mobile home. The Selectmen approved the request for abatement, and signed it.

Selectmen discussed and signed a refund check for John Thompson regarding disabled veteran's credit.

Chief Kay gave a status update. The inspection has been completed for the cruiser, and there are no problems/issues. Chief Kay stated that he is moving forward in the process to hire an Animal control officer. He will coordinate with the Selectmen's office to assist in scheduling drug testing. Chief Kay also discussed the salary increases for his department which was discussed last week during his non-public meeting with the Selectmen. He requested \$1.00/hr increase for Joe Pivrotto and himself (this would apply to the additional patrol hours for Chief Kay), and a \$.50/hr increase for Amanda Hutchins, Pete Chierichetti, and Gary Robinson. Francis motioned, seconded by Randy and approved to the increases.

Steve discussed the non-public meeting last week in which the Selectmen discussed the recent Town elections which were held on March 8, 2011. Steve motioned that the board make a motion that the election was valid no irregularities were found in School Board or Town Elections, seconded by Randy and approved. The Board acknowledged that they have accepted George Morrill's resignation as Deputy Town Clerk/Tax Collector.

Ed Bergernon of Bergernon Engineering was in attendance. He stated that he was here several years ago to discuss the Sanders Hill bridge, which they were not selected for. Mr. Bergernon discussed the Evans bridge with the Selectmen. Ed stated he has looked at the bridge, and the simple solution is to entirely replace it. Francis asked about the need to get permissions from the abutters. Ed stated that both temporary and permanent permissions will probably be needed. Mr. Bergernon stated that Bergernon Engineering is very interested in being part of the process as the Town moves forward in selecting an engineering firm.

Motion by Francis to accept the one year contract from Zero Sort for recycling, seconded by Randy and approved. The Selectmen signed the contract.

Scott Goodale was in attendance and discussion internet access and the Time Warner Cable contract. Scott stated that he would like to see the town work together to make it accessible. Francis stated that he was not in favor of the town paying for internet services. Chief Kay inquired as to whether the board would be willing to send a letter on behalf of the town addressing the issue of lack of internet service in Wentworth. Steve suggested that both Scott and Chief Kay possibly work together to draft a letter to present to the board for their support of the issue. Steve stated that he will contact Time Warner Cable and look into what needs to be done to expand.

Francis discussed the issue of property files containing attorney-client privileged information. Steve motioned that no documents, including those in property files contain any attorney-client privileged information. It is agreed that documents of this nature be separated and marked as such, and pulled out of the file prior to allowing public access. Motion seconded by Randy and approved.

The Administrative Assistant informed the Selectmen that she has been assigned to Jury Duty next week on Tuesday, April 5 & 6<sup>th</sup>. The office will be closed both of these days, but the regularly scheduled Selectmen's meeting will still occur at the regular time, on Tuesday at 6 p.m. The Administrative Assistant also informed the Selectmen that she is required to report for a second day of Jury Selection on Tuesday, April 19<sup>th</sup>, and the office will be closed on this day as well.

Discussion regarding recyclables. The Selectmen discussed the glass crusher at Rumney, and requested that the office notify Rumney that we wish to discontinue using it. Selectmen stated that

all tin and metal can go into the Zero Sort container; we will no longer sort these out. Zero sort anticipates installing the new containers April 11<sup>th</sup>, and will be at the Transfer Station on April 13, 15 & 16 to help set up and educate the residents on the new program. Randy stated that he can be available on April 11<sup>th</sup> for the delivery of the containers. Steve stated that he will be out of town on the 11<sup>th</sup>, but will be here on the 12<sup>th</sup> for the Selectmen's meeting. (He will be in Lebanon during the remainder of the week).
