Francis moved to open the meeting at 6:00 PM. This was seconded Ed and approved.

Linda Brown updated Selectman on the new State Computer Program. The State will replace the current computer with a new one and Selectmen signed the needed paperwork. Linda asked if Juanita could replace Kerry at the Tax Collector's conference and Selectmen agreed she could.

Kevin Kay talked to Selectmen about old telephone lines and problems with his service. He stated he has talked to NH Electric Coop without satisfactory results. Selectmen agreed to send a letter to Verizon, PUC, John Alger, and Ray Burton. Kevin wants to form a South Wentworth Residents Association to attempt to get adequate public service to that area. Selectmen advised Kevin that the road would be graded next week.

Francis recognized Ellie Murray for staining (the stain was provided by Ed Baker) the well cover in front of the Town Offices.

Ed moved to open the meeting at 6:00 PM. This was seconded by Francis and approved.

Francis moved to accept the minutes for July 20, 2004. This was seconded by Ed and approved.

Selectmen agreed to charge \$25 for copies of the Black/White 11x17 inch Town maps.

Selectmen signed a Timber Tax Warrant for Ducheneau M/L 07-02-06.

Walter Rebel talked about his concerns regarding the noise at the racetrack. It appears the race times are within the hours on the permit. Sgt. Kevin Kay said he has concerns about the amount of people (including children) in the pit area.

Jesse Bushaw from DRA talked to Selectmen about the assessing update required this year. The base value for land & buildings must be adjusted. Rick must confirm the measurements of the parcel and buildings he is using for the Sales. DRA will do QC check per RSA 21,J:11 on the Sales that Rick Vincent is using; Rick will have 30 days to adjust any challenges that DRA may report and update Selectmen on the progress. All taxpayers must be notified in writing, and a noticed Hearing held, and new assessments must be ready for the MS1, 9/1/04 (extended until 9/15/04). Selectmen will request an extension until October 1, 2004.

Francis moved to pay Rick Vincent for contracted services after authorized & approved by DRA. This was seconded by Palmer and approved.

Ed made a motion to adjourn at 8:22 pm. This was seconded by Francis and approved.
