**May 3, 2005 Meeting**

Present: Palmer Koelb, Francis Muzzey, John Millican and Janet Woolner

Palmer moved to open the meeting at 6:02 pm. This was seconded by John and approved.

John King talked about his major subdivision on Cheever Road and North Dorchester Road and improvements he will make on the road. He asked what is required and said his is willing to sign a promissory note and that he would like to start right a way and will work closely with the Road Agent.

Bobby said he will be crushing gravel this week and advised tree work has started on North Dorchester Road.

John moved to approve the driveway permit for Sherwood M/L 05-03-20. This was seconded by Francis and approved.

Francis made a motion to accept the Minutes of the April 26, 2005 meeting. This was seconded by Palmer and approved.

Rick Vincent talked to Selectmen and said he has reconsidered and would offer the Town a new contract , however, at a higher rate \$75/hr for assessing and \$40 for data entry. Francis moved to go into non-public session per RSA 91-A:3, II (c), for the purpose of matters which, if discussed in public, would likely affect adversely the reputation of any person unless such person requests an open meeting; however, this cannot be used to protect a person who is a member of your Board, Committee or Subcommittee. This meeting to include only Rick Vincent and the Board of Selectmen. (The Administrative Assistant was also asked to leave the room). This was seconded by Palmer and approved. John Downing asked to go on record as to questioning why a non-public session was necessary. Francis moved to come out of non-public session. This was seconded by Palmer and approved. No decisions were made.

Doug Campbell talked to Selectmen about reopening his gravel pit on East Side Road, M/L 05-05-12, near the bridge on the Warren Wentworth Town line. He plans to have Pike, on behalf of the State of NH, excavate approximately 15,000 yards of material for the Route 25 project. Doug will complete the Intent to Excavate and Doug advised he still has the \$5,000 bond with Pemi Bank in Plymouth. There remains a question whether the Selectmen or the Planning Board has the responsibility for authorizing this.

Palmer discussed having the Wentworth eighth grade pick up trash along Buffalo and East Side Roads for \$100 to support the Schools Fund Drive.

Selectmen approved the appointment of Angela Comeau for Library Trustee, signed a Timber Tax Warrant for \$3,646.04, and signed a revised septic design for Rebele M/L 13-06-02.
