Steve motioned to open the Budget Hearing at 5:08 pm, seconded by Pete and approved.

The Board discussed with those present the proposed 2015 Budget. Some corrections were noted: The Poll hours will be 11am to 7 pm, and Steve requested the insertion of the wording "By Petition" regarding WA #26.

Steve motioned to close the Budget Hearing at 6:14 pm, seconded by Pete and approved.

Steve motion to open the public meeting at 6:14, seconded by Pete and approved.

Chief Kay gave a status update. The Department is getting caught up with case work. The Cruiser working fine, he is still trying to gather costs for the new cruiser. Chief Kay stated that the Police Department assisted last night with a fire on Atwell Hill Road.

Pastor Margaret Bickford addressed the Board and thanked them for allowing her to be on the agenda. She inquired if the Town has any suggestions for the Church to become more involved and help where needed. She asked if the Board has projects, task force or some other involvement in which they can offer support. Steve mentioned the upcoming 250 year celebration, and Pastor Margaret stated they are working on getting the church on the National Registry. Francis also mentioned Market Day involvement. She stated the church desires to become more visible and more active, and the members are willing to get involved. Palmer stated that they used to have a duck race that raised money.

This exemption shall extend to any application for assistance or tax abatement or waiver of a fee, fine, or other levy, if based on inability to pay or poverty of the applicant. Welfare Application, seconded by Pete and approved.

The Board discussed and granted a request for support, and discussed the Town Workfare program with the Applicant.

Steve motioned to adjourn the Non-Public meeting at 7:20 pm, seconded by Pete and approved.


